I. Use Cases & Adoption

Question about machine-machine interaction issues, with indirect impacts on people. It would be good to have a use case for this. One suggestion was Air Traffic Control, another was for discrimination against device type, which impacts people who do not have or cannot use (eg due to accessibility issues) that device. Trish gave example of hands-free engagement with local authorities in the UK using Alexa.

Looking at how this relates with legal frameworks. Some examples of ways to elicit this, paper on organizational bias issues. Largely comes from the top – high-level leadership examples set the tone that impacts how lower levels act. Gerlinde requested a reference for 'leadership overview of bias' paper, and Mark pointed out that this is based on face recognition not all biometrics. This means the issue becomes identification morphing into surveillance.
