## **IEEE Patent Policy**



#### Participants have a duty to inform the IEEE

- Participants <u>shall</u> inform the IEEE (or cause the IEEE to be informed) of the identity of each holder of any potential Essential Patent Claims of which they are personally aware if the claims are owned or controlled by the participant or the entity the participant is from, employed by, or otherwise represents
- Participants <u>should</u> inform the IEEE (or cause the IEEE to be informed) of the identity of any other holders of potential Essential Patent Claims

#### **Ways to inform IEEE**

- Cause an LOA to be submitted to the IEEE-SA (patcom@ieee.org); or
- Provide the chair of this group with the identity of the holder(s) of any and all such claims as soon as possible; or
- Speak up now and respond to this Call for Potentially Essential Patents

If anyone in this meeting is personally aware of the holder of any patent claims that are potentially essential to implementation of the proposed standard(s) under consideration by this group and that are not already the subject of an Accepted Letter of Assurance, please respond at this time by providing relevant information to the WG Chair

#### Other guidelines for IEEE WG meetings

- All IEEE-SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.
  - Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
  - Don't discuss specific license rates, terms, or conditions.
    - Relative costs of different technical approaches that include relative costs of patent licensing terms may be discussed in standards development meetings.
      - Technical considerations remain the primary focus
  - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
  - Don't discuss the status or substance of ongoing or threatened litigation.
  - Don't be silent if inappropriate topics are discussed ... do formally object.

#### **Proposals for Revision of P&P**

- In Section 6 (Meetings):
  - For notice for face-to-face meetings: change from 15 days notice to 30 days
  - For notice for electronic meetings: change from 15 days to 10 days
- For Section 4.1.1 (Working Group Membership Status):
  - Losing voting rights after missing 3 meetings (instead of the 2 now specified)
  - No change in needing to attend 2 meetings in a row to gain right to request voting status



Please rank the clinical topics in order of importance for P1752 to address first



#### **Proposed Subgroup Plans**

- Schema subgroups
  - Sleep: launch first
  - Cardiovascular: launch in next month
- API subgroup: to launch after schema subgroups, after API presentation
- Provenance: defer till later in 2018



#### **Subgroups: Policies and Procedures**

#### 5.0 Subgroups of the Working Group

The Working Group may, from time to time, form subgroups for the conduct of its business. Voting Membership in the subgroup is granted to any participant of the Working Group. Such formation shall be explicitly noted in the meeting minutes. At the time of formation, the Working Group shall determine the scope and duties delegated to the subgroup, and may decide to allow participation of persons who are not Working Group members and specify the terms and conditions under which they participate in the subgroup. Any changes to its scope and duties will require the approval of the Working Group. Any resolution of a subgroup shall be subject to confirmation by the Working Group.

The Chair of the Working Group shall appoint, and may dismiss, the Chair of the subgroup.



#### Sleep Schema Subgroup

- Scope
  - Determine domain scope
- Duties, same as for all schema subgroups
  - Common and clinically important attributes
  - Proposed modified and new schemas
  - Mappings/relationships to other sleep schemas
- Participation of persons who are not Working Group members and specify the terms and conditions under which they participate in the subgroup.
- Chair (self)nomination to ida@openmhealth.org



#### Sleep Schema Subgroup First Steps

- Charlotte's proposal's first steps:
  - Sprint0: Get ready to Start
  - Sprint1: Gather information from devices that support this function
  - Sprint2: Study/Understand the existing work (including OpenmHealth, FHIR, etc.)
- "get the subgroup familiar with the clinical important attributes of sleep"
- sleep is a complex phenomenon
