IEEE Policies

IEEE SA Call for Patents

Participants have a duty to inform the IEEE

- Participants <u>shall</u> inform the IEEE (or cause the IEEE to be informed) of the identity of each holder of any potential Essential Patent Claims of which they are personally aware if the claims are owned or controlled by the participant or the entity the participant is from, employed by, or otherwise represents
- Participants <u>should</u> inform the IEEE (or cause the IEEE to be informed) of the identity of any other holders of potential Essential Patent Claims

Early identification of holders of potential Essential Patent Claims is encouraged

Ways to inform IEEE

- Cause an LOA to be submitted to the IEEE-SA (patcom@ieee.org); or
- Provide the chair of this group with the identity of the holder(s) of any and all such claims as soon as possible; or
- Speak up now and respond to this Call for Potentially Essential Patents

If anyone in this meeting is personally aware of the holder of any patent claims that are potentially essential to implementation of the proposed standard(s) under consideration by this group and that are not already the subject of an Accepted Letter of Assurance, please respond at this time by providing relevant information to the WG Chair

Other guidelines for IEEE WG meetings

- All IEEE-SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.
 - Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
 - Don't discuss specific license rates, terms, or conditions.
 - Relative costs of different technical approaches that include relative costs of patent licensing terms may be discussed in standards development meetings.
 - Technical considerations remain the primary focus
 - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
 - Don't discuss the status or substance of ongoing or threatened litigation.
 - Don't be silent if inappropriate topics are discussed ... do formally object.

IEEE SA Individual Participation

Participant behavior in IEEE-SA activities is guided by the IEEE Codes of Ethics & Conduct

- All participants in IEEE-SA activities are expected to adhere to the core principles underlying the:
 - IEEE Code of Ethics
 - IEEE Code of Conduct
 - The core principles of the IEEE Codes of Ethics & Conduct are to:
 - Uphold the highest standards of integrity, responsible behavior, and ethical and professional conduct
 - Treat people fairly and with respect, to not engage in harassment, discrimination, or retaliation, and to protect people's privacy.
 - Avoid injuring others, their property, reputation, or employment by false or malicious action

Participants in the IEEE-SA "individual process" shall act independently of others, including employers

- The <u>IEEE-SA Standards Board Bylaws</u> require that "participants in the IEEE standards development individual process shall act based on their qualifications and experience"
- This means participants:
 - Shall act & vote based on their personal & independent opinions derived from their expertise, knowledge, and qualifications
 - Shall not act or vote based on any obligation to or any direction from any other person or organization,
 including an employer or client, regardless of any external commitments, agreements, contracts, or orders
 - Shall not direct the actions or votes of other participants or retaliate against other participants for fulfilling their responsibility to act & vote based on their personal & independently developed opinions
- By participating in standards activities using the "individual process", you are deemed to accept these requirements; if you are unable to satisfy these requirements then you shall immediately cease any participation





IEEE-SA standards activities shall allow the fair & equitable consideration of all viewpoints

- The <u>IEEE-SA Standards Board Bylaws</u> (clause 5.2.1.3) specifies that "the standards development process shall not be dominated by any single interest category, individual, or organization"
 - This means no participant may exercise "authority, leadership, or influence by reason of superior leverage, strength, or representation to the exclusion of fair and equitable consideration of other viewpoints" or "to hinder the progress of the standards development activity"
- This rule applies equally to those participating in a standards development project and to that project's leadership group
- Any person who reasonably suspects that dominance is occurring in a standards development project is encouraged to bring the issue to the attention of the Standards Committee or the project's IEEE-SA Program Manager

P1752.2 Cardiorespiratory Subgroup

September 29, 2022

Attendance, introductions, and review of prior minutes (*incomplete*)

Planned presentation (postponed)

Discussion:

- HRX San Diego held September 8-10, 2022: Connection to industry members, FDA, physicians & scientists, IT 3rd party services, users, etc. in the cardiorespiratory domain represented at this meeting (outreach about P1752.2 cardiorespiratory work)... and emerging trends of cardiorespiratory data collection and analytics
- Consideration of effective outreach to key stakeholders, and follow up of those already approached who are interested.
- Value propositions of Open mHealth to be developed with conciseness/clarity... examples:
 - Lightweight interoperable cardiorespiratory data standard
 - Data contextuality enabled by broadbased Open mHealth mandate

Action items:

- Continuation (part 2) of "Recovery from Physical Activity The Cardiorespiratory Response and Mobile Health Use Cases"
- Other use case proposals fitting the Health Care paradigm: Volunteers requested
- Proposal for orientation meeting for targeted stakeholders to win awareness and committed engagement





P1752.2 Metabolic Subgroup

- Discussed a set of draft schemas for an initial set of measures
 - Definitions
 - Units of measure
 - Contextual elements
- Blood glucose unit-value, blood glucose
- Time in range [TIR], above range [TAR], below range [TBR]
- Blood glucose ranges (cut-off values for low, very low, high and very high)
- Ambulatory glucose profile for CGM http://www.agpreport.org/agp/agpreports
- Ambulatory glucose profile for SMGM

- Discussed addition of data elements as contextual metadata for BG:
 - o percent_time_sensor_active
 - o numer_of_days_device_worn
