7.1. SCC 14.1

7.1.1.SI 10, American National Standard for Metric Practice

There has been no significant activity in recent months. However, a new SI Brochure is expected in the coming months and interested parties should be on the lookout for this document.

7.2. SCC 14.2

7.2.1. IEEE 270, IEEE Std Definitions for Selected Quantities, Units, and Related Terms, with Special Attention to the International System of Units (SI)

There is no current activity with this document. This standard is valid until 31 December 2022.

Task Force (led by Jim Frysinger) is reviewing 260.3, 270.6, and other ancillary SCC 14 documents to see which of these standards are recommended to remain stand alone documents, which could be combined, and which should be withdrawn. Please submit your comments to the Task Force ASAP.

7.3. SCC 14.3

7.3.1. IEEE 260.1, IEEE Std Letter Symbols for Units of Measurement

Project has been delayed pending completion of P1541. Good progress from the WG thus far. One or two more drafts, and the WG expects to be ready for ballot. Final draft by this fall and will circulate for ballot approval.

7.3.2. IEEE 1541, IEEE Std for Prefixes for Binary Multiples

WG is working to resolve the ballot comments and hopes to go into a recirculation ballot soon. Will be administratively withdrawn at the end of the year, but based on current progress, the WG expects to restore the document in early 2019.

7.4. SCC 14.4

7.4.1. IEEE 280, IEEE Std Letter Symbols for Quantities Used in Electrical Science and Electrical Engineering

Randy Curey has accepted the role as WG chair. Draft is being circulated for comment. Feedback on the draft is appreciated.

7.5. SCC 14.5

7.5.1. ANSI 260.4, American National Standard Letter Symbols and Abbreviations for Quantities Used in Acoustics

Standard has been approved by RevCom and is in the hands of IEEE Editorial staff.

This document should be published in the next few months.

7.6. SCC 14.6

7.6.1.IEEE 945, IEEE Recommended Practice for Preferred Metric Units for Use in Electrical and Electronics Science and Technology

Successfully passed on the initial ballot, although there are some comments to resolve. WG aims to initiate a recirculation ballot prior to Thanksgiving and submit to RevCom in December.

7.7. SCC 14.7

7.7.1. IEEE 947, IEEE Guide for Identification of Alternative Metric Devices for Valves, Fittings, Threads, and Flanges

New Working Group. Scope, Purpose, and PAR content well defined, but working on the balance of the document. Soliciting input.

8.1. Website Update
