- a. Page 1: 1.3 Word usage
 - As this is standard, should mostly have "shalls" throughout the document.
- b. Page 7: 10 Conventions
 - As Conventions are not requirements, "should" will be used a good deal.
 - Choice of words for Section were reviewed and approved on basis that this section is an observation of what is done, not a statement of requirement.
- c. General: 11.1
 - Which font to use?
 - Have mostly used Callibri font for symbols. However, as some symbols are only available via the font Cambri Math, there is a mix of symbols which use Cambri Math.
 - Did not find guidance from the 2021 IEEE SA Standards Style Manual for a preferred font for symbols.
 - Decision: Use Callibri and Cambri Math as needed with decision of which font to be made, for now, on a case by case evaluation.
- d. General Abbreviation "cf", which is the abbreviation of confer/conferatur, meaning "compare", is change to "see."
- e. Corrected 11.2.13 equation. Added note, "(For a different meaning of this symbol, see 11.4.3.)"
- f. Corrected 11.2.14 (applied in General)
 - Original "NB" which is latin abbreviation for Nota bene which means "note well".
 - Decision, should typically delete the "NB".
 - Added note, "(For a different meaning of this symbol, see 11.4.4.)"
- g. Eric Shirley requested copy of latest WORD draft to do off-line review.
- h. 11.2.16 & 11.2.17: The Delta symbol was previously much larger.
 - No option to increase. Keep as is.
- i. 11.2.21 & 11.2.22: Discussion of a single or double lines for the equal portion of the symbol under the great than or less than symbols.
 - Agree to use single line.
 - Agree to not show the double line option as this is not in common practice.
- j. 11.2.23 & 11.2.24: No changes were made after careful review for "much less than" and much greater than" respectively.

- k. 11.2.25 & 11.2.26: Updated note to read, "also used (preferably in Roman non-italics) with ...".
 This agrees with IEEE Std 260.1 (for minute (place angle) and second (place angle) use the non-italic symbol.
- I. 11.2.31: Previous version had the "p" not italicized. This is corrected to change the "p" to italics.
- m. 11.2.33 to 11.2.36: Corrected draft from "postulation" to "postulational" as word is used as an adjective. Also, "postulational" matches previous version.
- n. 11.2.37: No change is made. Clarified that the Ellipse is meaning et cetera. The et cetera is in italics as et cetera is Latin.
- o. 11.11.2.2: Application column, confirmed no change be M(a, b, z) NIST Handbook of Mathematical Symbols (<u>DLMF</u>).
- p. 11.1.4: Ig is changed to log
 Discussed items 11.5.2.1.2 to 11.5.2.1.5. Noted that changes are needed but changes were not yet completed.
- q. WORD cross-references were through 11.2.14.
- r. Stopped/completed:
 - Completed review through 11.2.37 which completed review of Table 11.2.
