



## IEEE SSIT Standards Committee Meeting #53 Minutes Thursday, 20<sup>th</sup> April 2023 20:30 – 22:00 (UTC)

#### 1 CALL TO ORDER

The meeting was called to order at 20:35 (UTC).

#### 2 ROLL CALL AND DISCLOSURE OF AFFILIATION

Roll call and disclosure of affiliation. A quorum, 7 of 15 voting members, was not present. Apologies from Ben B, Stephanie C, and Jane A. The meeting proceeded as an information session.

#### 3 WORKING GROUP REPORTS

## 3.1 P2895 – Standard Taxonomy for Responsible Trading of Human Generated Data

Report distributed before meeting. Angelo F provided the following information:

- An extra session is being run each month to create the draft.
- There has been a small increase in members. Member diversity is good. There was a quorum in March but not April.
- The issue of when data trading commences is still to be resolved. At present there is no protection in law until the data changes hands.
- An example of unintended trading is genome data, as it includes data of the person's ancestors which generates privacy issues.
- The metaverse involves data trading.

# 3.2 P7011 – Standard for the Process of Identifying and Rating the Trustworthiness of News Sources

The WG advised that at its meeting on April 7<sup>th</sup>, it decided to apply for a 12-month extension.

The SC discussed how the engineering development environment had charged due to AI. This is because advanced AI engines can adapt their responses after deployment. This is markedly different from the previous generations of engineering artifacts in which their function was fixed at design. This AI adaptation ability means that greater consideration needs to be given to the ethical issues surround the design, development, and deployment of modern systems.
