#### 1 CALL TO ORDER

The meeting was called to order at 20:33 (UTC).

#### 2 ROLL CALL AND DISCLOSURE OF AFFILIATION

Roll call and disclosure of affiliation. A roll call was made, and the meeting had a quorum, 6 of 12 voting members present, see attendance list at end of minutes. Additional voting members joined the meeting just after the roll call.

#### 3 AGENDA

#### 5 APPROVAL OF MINUTES OF PREVIOUS MEETING

Moved Peter W, seconded Peter R, that the minutes of meeting #64 of 21st March 2024 be approved, carried.

#### 6 ISTAS 2024

The Chair, Ruth L, raise the possibility of SSIT/SC involvement and promotion of ISTAS 2024 to be held in Puebla, Mexico, from September 18-20, 2024. The deadline for paper submission is May 31<sup>st</sup>. The Chair, Ruth L, request SC members to put forward ideas by April 30<sup>th</sup> of how the SC could be involved in ISTAS 2024.

#### 7 PAR P3422 - RECOMMENDED PRACTICE FOR METAVERSE ECOSYSTEM REFERENCE MODELS

Discussion was around the SC becoming a Co-standards committee for PAR P3422. PAR P3422 was distributed with version 2 of the agenda. The SC for this PAR is IEEE Computer Society/Standards Activities Board(C/SAB). WG P3422 has had its 2<sup>nd</sup> meeting and is going well. If SSIT/SC is to become a co-standards committee for PAR P3422 then an SSIT/SC member will need to volunteer to be become the liaison person. The Chair, Ruth L, and Program Manager, Christy B, will explore this idea with the respective Chair and Program Manager of WG P3422.

#### 8 WORKING GROUP REPORTS

#### 8.1 P2895 – Standard Taxonomy for Responsible Trading of Human Generated Data

The report was distributed prior to the meeting. The Chair, Angelo F, provided additional comments:

- The use of the word "trading" in the PAR title has caused considerable angst among potential WG members.
- The PAR will require an extension, as the current expiry date is 31st December 2024.
- As the PAR needs to go back to NesCom for approval it may be an opportune time to update the title and the scope of the PAR.

General discussion took place. The following outcome was suggested:

- The project title be changed to "Standard Taxonomy for Responsible Use of Data that Represents Humans".
- That the project number be retained.
- That the scope be rewritten, and the modified PAR be submitted to the SC for approval.
- That a 3-year extension be applied for.

Chair, Angelo F, to consider the above suggestion. Note: To be considered at the next SC meeting the revised PAR will need to be submitted to the Program, Manager, Christy B, by April 25<sup>th</sup>.

#### 8.2 P7012 – Standard for Machine Readable Personal Privacy Terms

The report was distributed prior to the meeting. The SC was informed that final revision of the draft standard was nearly completed. It is expected to be approved by the WG within the next two weeks. This will be done via e-ballot. The process to go to ballot will then be started.

## 8.3 P7016.1 – Standard for Ethically Aligned Educational Metadata in Extended Reality (XR) & Metaverse

The report was distributed with version 2 of the agenda. Report was noted by SC.

### 8.4 P7017 – Recommended Practice for Design-Centered Human-Robot Interaction (HRI) and Governance

The report was distributed prior to the meeting. Chair, Yueh-Hsuan W, spoke to slides in Attachment 1.

#### 9 OTHER PAR ACTIVITIES

#### 9.1 IEEE SA Foundational Technology (FT) – Metaverse Sub-Group

Carol McDonald has volunteered to be liaison person for P3079.3.2, Standard for a Framework for Privacy Protection through Identifiability Management Arising from Avatar Interaction, between C/SABSC and SSIT-SC. Angelo F to report on progress on the form of liaison for P3079.3.2. Report deferred to the next meeting.

#### 9.2 Other Standards Committees

Chair, Ruth L, reported that a meeting between SSIT-SC and Computer Society's Artificial Intelligence Standards Committee (C/AISC) was held on Friday 2<sup>nd</sup> February AEDT. The meeting was beneficial. Project Manager, Christy B, to organize a follow-up meeting. Action deferred to the next meeting.

#### 10 LIAISONS

#### 10.1 IC22-006-01 Best Practice Guide to Developing Ethically Aligned Standards

The Chair, Ruth L, reported that an application had been made to TAB/COS to complete this work and undertake a workshop at ISTAS 2024. The link to the work can be found here https://miro.com/app/board/uXjVPDyKOm0=/.

#### 10.2 Dignity, Inclusion, Identity, Trust and Agency (DIITA)

The last meeting was held on March 28<sup>th</sup> AEDT. An overview on the new working group, *Empowerment in AI* was given by Anna Hovsepyan.

- Anna provided background of this group, which was a committee in another program, transitioning to DIITA. They have a draft paper they hope to finalize and get to be published.
- This is about how technology impacts power balances and empowerment / disempowerment. The purpose of the activity is for technologists to ask, "when developing a new technology, who am I empowering?"
- Areas considered have included regulation.
- Three parts and may be published separately:

- Introduction
- Legal issues
- Conclusion
- May turn into a series of papers after, as topics surface.
- At next meeting, will discuss the drafts.

#### 10.3 Smart Villages and Smart Cities

The issue of SSIT liaison with the Smart Villages and Smart Cities initiatives was discussed. The Chair, Ruth L, to discuss with Arsalan Abtahi on his availability to represent SSIT on standards work, Angelo F for general liaison on Smart Cities, and David G on Smart Villages.

#### 10.4 Glossaries for Sustainability and AI Ethics

The Linux Foundation announced the following glossary for Generative AI <a href="https://genaicommons.org/glossary/">https://genaicommons.org/glossary/</a>. The Linux Foundation would like to work with IEEE to broaden the definitions. Vice Chair, Karen B, has had discussions with Karen McCabe, and there is a willingness for both organisations to work together. Vice-Chair, Karen B, to continue to liaise with Karen McCabe and report back to the next meeting.

P2863 - Recommended Practice for Organizational Governance of Artificial Intelligence. An AI Dictionary or Taxonomy is being created for this standard, possibly before the scheduled IEEE SA Board Series in June. Could this assist SSIT/SC in our need for a Sustainability Glossary? Will it leverage the EAD Glossary from 2019? John Havens, staff, to report on discussion with IEEE SA and Karen McCabe at the next meeting.

#### 11 Business Arising from Previous Meetings

#### 11.1 SSIT BoG Budget Submission

The SSIT BoG will be issuing a call for budget submissions from all committees (including SSIT/SC) for financial year 2025 (FY2025 is also calendar year 2025). Chair, Ruth L, reported that the starting point for the FY2025 will FY2024 expenditure. As SSIT/SC and WG did not have any budget allocation in FY2024 it is imperative that SSIT/SC and WGs prepare and submit a bid for an allocation for FY2025. All SC members and WGs are requested to submit their requests to the Chair, Ruth L, by June 1st.

The suggestion was made that a standard SSIT/SC presentation pack be develop. The Chair, Ruth L, report that she had recently presented to the Australian CSIRO/Data 61 National AI Centre on April 11<sup>th</sup>. This presentation could be the basis of the presentation pack. The Secretary, Peter R, to create a presentation folder in SSIT/SC iMeet. Chair, Ruth L, upload presentation to this folder.

#### 11.2 Transactions on Privacy

Angelo F reported on his discussions with the inaugural Editor-in-Chief, Christopher W. Clifton from Purdue University, to see if the broader social aspects of privacy will be covered by the Transaction. The outcome of which was: For SSIT to become a co-sponsor of Transaction on Privacy the following actions are needed:

- Confirm SSIT interest. DONE
- Get President Kun's SSIT approval (internal process)
- Assign an AE (Associate Editor) 2-year term (renewable once)
- Getting Computer Society Approval (internal governance)
- AE becomes a non-voting member of the committee.

Angelo F to coordinate with Chair, Ruth L, to obtain SSIT approval.

#### 11.3 NIST AI Safety Consortium

Vice-Chair, Karen B, reported IEEE had contributed via Karen McCabe and is awaiting feedback on the next steps from NIST. Vice-Chair, Karen B, to continue liaison and report back to the next meeting.

#### 11.4 Development of digital twins of the earth

#### Sigmund K report:

• Study group in Oceanic Engineering Society (OES): is running, a PAR titled "Recommended Practice for the Development of Digital Twins of the Earth" is planned to be submitted to NesCom with Deadline April 26 (see here if interested – work in progress:

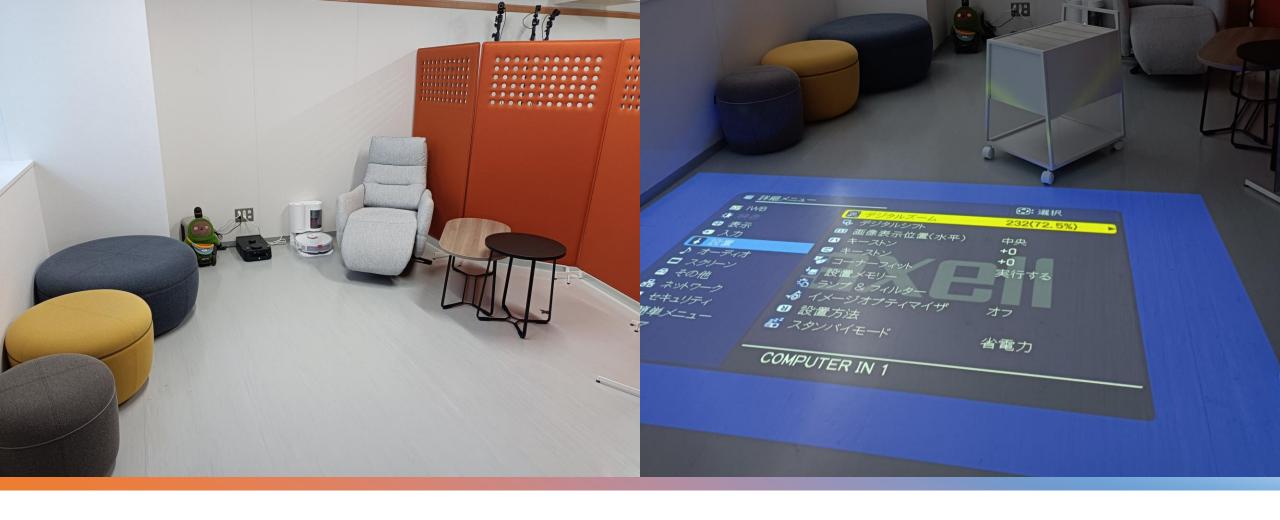

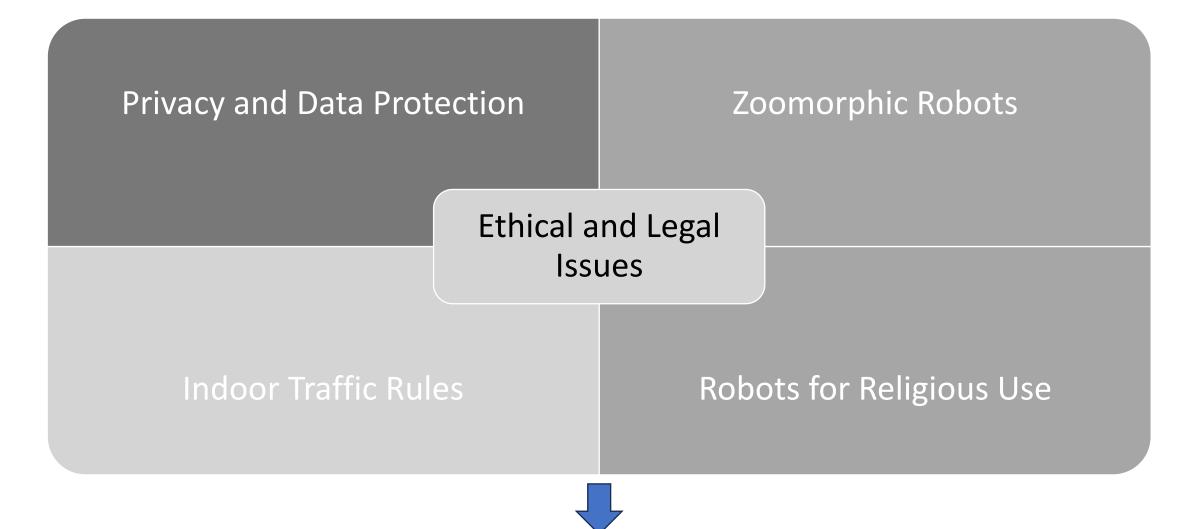
