1 CALL TO ORDER

Noting P7999 Series will be the test case for how SSIT-SC operates as a co-standards committee. P7999 to use SSIT-SC WG reporting and see how that works.

The draft document has been reviewed by the SSIT-SC officers and is expected to be submitted by 9th May for consideration by the next Industry Connections committee (ICCom) meeting on 10th June.
